

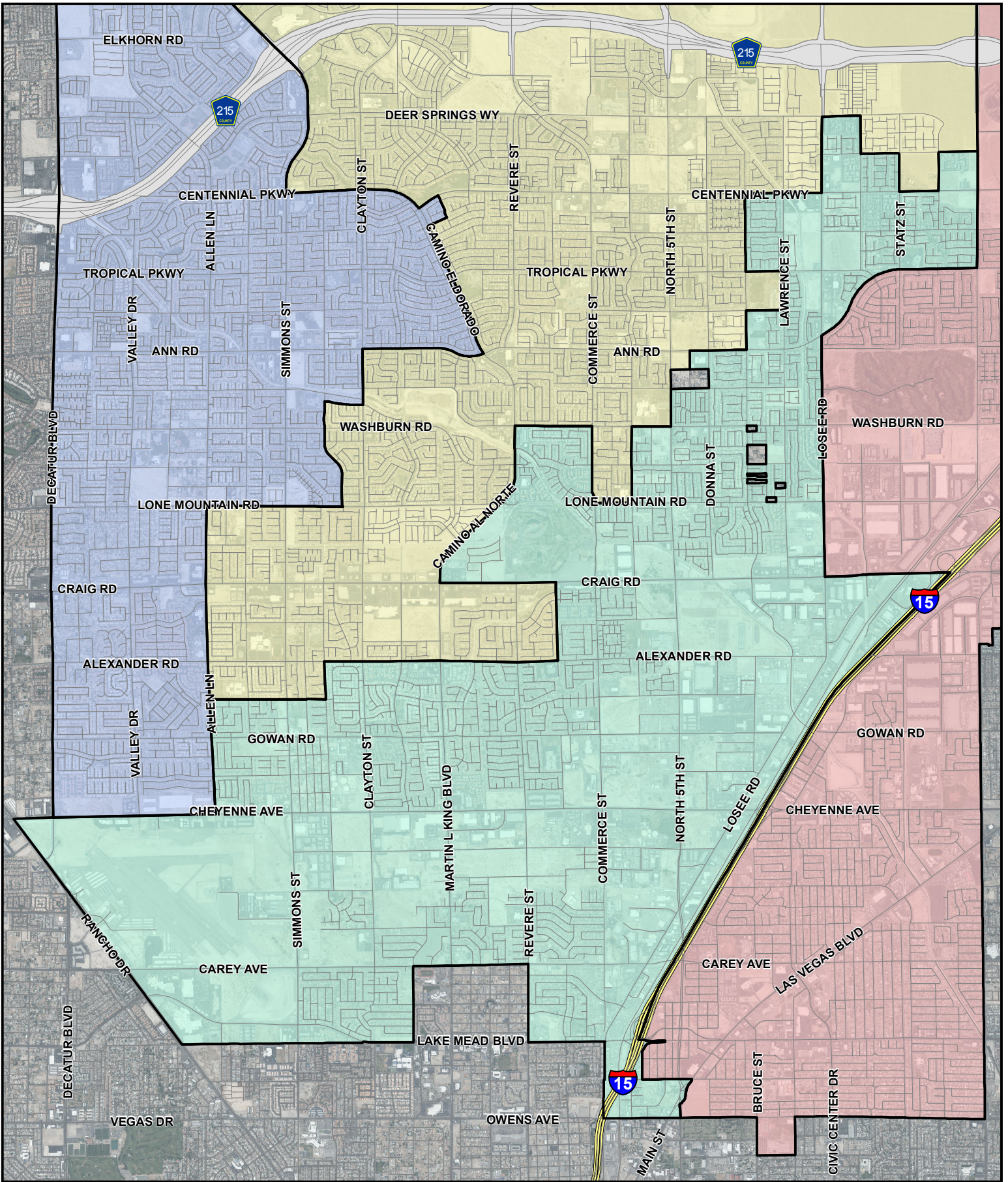

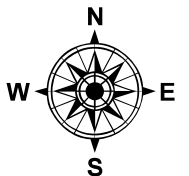

Nevada Open Meeting Law Waiver

WAIVER OF NOTICE IS REQUIRED UNDER NRS 241.033(1) TO ALLOW THE CITY COUNCIL TO CONSIDER THE CHARACTER, MISCONDUCT, OR COMPETENCE OF A PERSON TO BE APPOINTED TO A BOARD, COMMISSION OR OTHER PUBLIC BODY FOR THE CITY OF NORTH LAS VEGAS.

The City Council for the City of North Las Vegas (City) will be considering your appointment to a City board, commission or other public body on a future posted agenda. Pursuant to NRS 241.033(1), in order to consider the professional competence of an applicant, notice needs to be provided to that person of the time and place of the meeting in compliance with such statutory provision.

By agreeing below, it is confirmed that I will be provided notice of the meeting at which my appointment will be considered by the City Council. Further, I knowingly and voluntarily am waiving my rights to all written notice requirements under NRS 241.033(1) pertaining to my qualifications, competence and character to hold this appointment and consent to evaluation of my character and competence by the City of North Las Vegas City Council in a public meeting. Further, I acknowledge that I may, at any time, withdraw both this waiver and the related application for my appointment.

City of North Las Vegas City Council Appointment FAQs

1. What are the requirements for applying for the Ward 2 vacancy?

Section 2.08.060 Qualifications of Mayor, Municipal Court Judge and Council Member

B. Each Council member:

1. Must be a qualified elector who has resided in the ward which he or she represents for at least 30 days immediately preceding the last day for filing a declaration of candidacy for his or her office; and
2. Must continue to live in the ward he or she represents, except that the changes in ward boundaries made pursuant to the City Charter or the chapter will not affect the right of any elected council member to continue in office for the term for which he or she was elected.

Title 24 Nevada Revised Statutes (NRS): NRS 293.055 “Elector” defined.

“Elector” means a person who is eligible to vote under the provisions of [Section 1 of Article 2](#) of the Constitution of the State of Nevada.

(Added to NRS by [1960, 236](#))

Applicants must be 18 years old, a registered voter, and resident of Ward 2 in the City of North Las Vegas at least 30 days prior to submitting the application. A government issued photo identification and proof of residency are required at application.

Examples of proof of residency includes:

- Municipal Utility Bill in the applicant’s name
- Mortgage Statement in the applicant’s name
- Rental Agreement that is in the name of the applicant

2. Are there any additional documents needed to support my application? Yes.

- Your resume (to include employment history)
- A copy of your driver’s license
- Financial Disclosure Statement (*Nevada Secretary of State How to Guide for FDS is provided for review and guidance.*)
- Copy of Voter Registration Card

3. Will my application be accessible to the public

Yes, applications will be posted on the City of North Las Vegas website upon submission.

4. When will this term start?

North Las Vegas City Council is tentatively scheduled to meet in a Special Council Meeting on December 15, 2022, at 4:00 P.M. to deliberate and recommend the appointment of a Councilmember for Ward 2.

Immediately following Council's approval, the newly appointed council member will be sworn-in and term will take effect.

5. How long is this term?

This appointment will be a two (2)-year appointment, ending November 30, 2024. The appointee shall serve until the next general municipal election and until his or her successor is elected and qualified.

6. Is there a cost associated with applying?

There is no filing fee for this appointment.

7. Is this a paid position?

Yes, the annual salary is \$ 49,731.92, effective 7/5/2022.

8. Is this a full-time position?

Councilmembers' schedules vary and include appointments to several boards and commissions, as well as evening meetings and City Council meetings.

9. When are the Council Meetings held?

Council Meetings are held on the first and third Wednesday of each month starting at 4:00 PM in the North Las Vegas City Council Chambers at City Hall.

Additionally, attendance at various board and committee meetings may be required upon appointment.

FDS Reports - Who is required to file?

A Financial Disclosure Statement (FDS) is required to be filed with the Secretary of State by all state and local Elected officials and Appointed public officers by January 15 of each year they are in office. Failure to file such a form may result in a civil penalty. [[NRS 281.581\(3\)](#)].

Judges and judicial candidates are required to file a FDS with the Administrative Office of the Court (AOC).

There are three types of Financial Disclosure Statements:

- Annual
- Appointment
- Candidate

ANNUAL FDS

Campaign Finance Reporting Requirements

- The ANNUAL FDS is due not later than January 15th and covers the preceding calendar year (NRS 281.559(1)(b) & NRS 281.561(1)(b)). This must be filed by the following public officers:
- All public officers holding an elected office, regardless of salary
- All public officers holding a non-elected office and whose annual salary is \$6,000 or more
- All state legislators

APPOINTMENT FDS

Campaign Finance Reporting Requirements

- The APPOINTMENT FDS is due not later than thirty (30) days after the public officer's date of appointment (NRS 281.559(1)(a)). This must be filed by the following public officers:
- All public officers appointed to an elected office who are entitled to receive \$6,000 or more annually
- All appointments to the state Legislature
- All public officers appointed to fill the unexpired term of an elected or appointed public officer

CANDIDATE FDS

Campaign Finance Reporting Requirements

- The CANDIDATE FDS is due not later than ten (10) days after the end of candidate filing and covers the preceding calendar year plus January 1 of the current year through the last date of candidate filing (NRS 281.561(1)(a)). This must be filed by the following public officers:
 - All candidates seeking public office who are entitled to receive \$6,000 or more annually
 - All candidates for the office of state Legislator
 - All public officers previously elected to the office they are serving (e.g. incumbents) regardless of salary

How to File an FDS Report

1. Access the Secretary of State's website at: www.nvsos.gov
2. Select the Campaign Finance blue button (left side of screen)
3. You will be directed to the "AURORA Campaign Finance Disclosure" page
4. Click on: Login to File Reports
5. Enter your email and password
6. Click on "File A Report" blue button and on next page click "Financial Disclosure Statement"
7. A listing will appear. Click the button next to the FDS report you need to file (nothing happens so scroll down on the page)
8. Make sure your contact information is correct. Answer two mandatory questions (length of residence and length of residence in district) and click Save and Proceed.
9. This will bring up the report. Follow prompts to file.

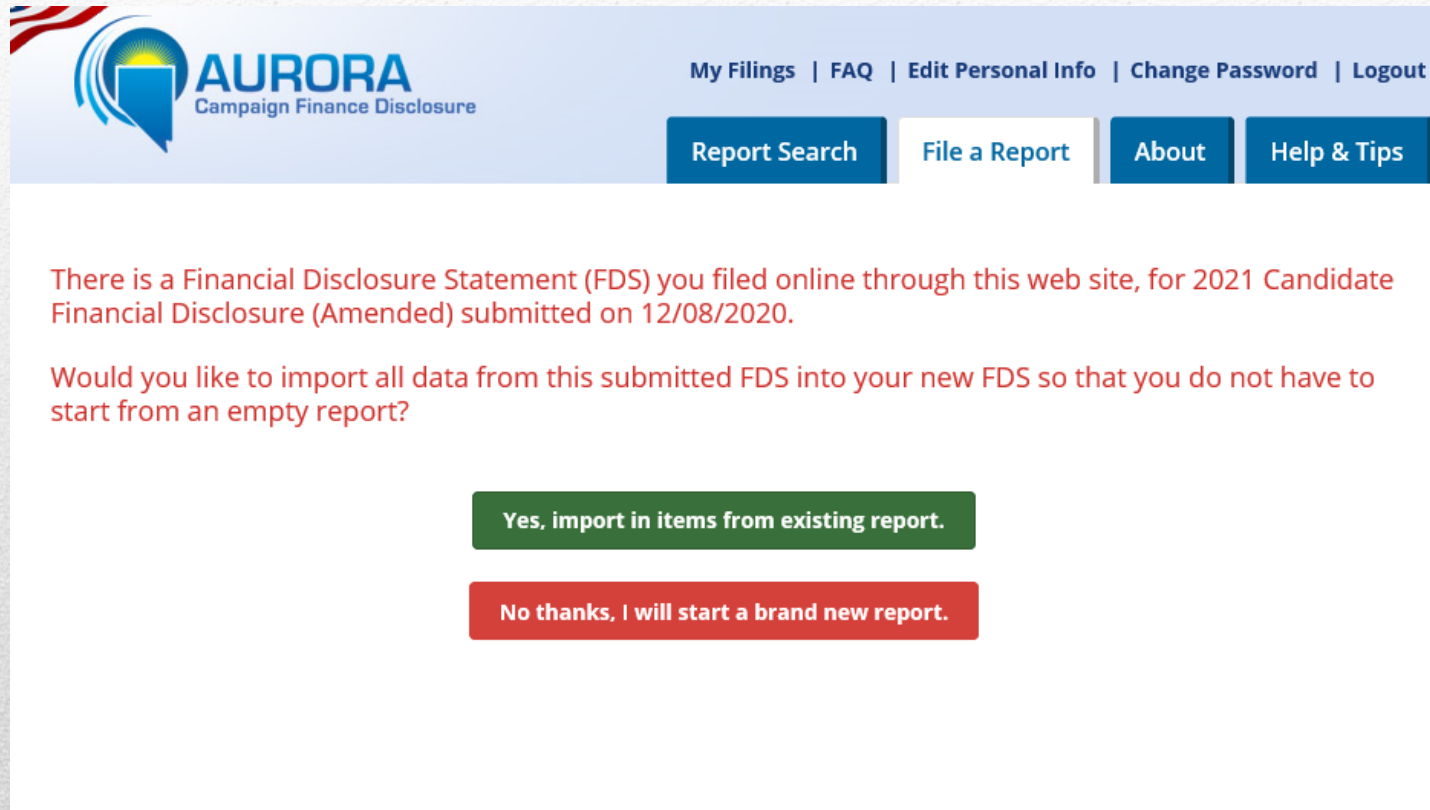

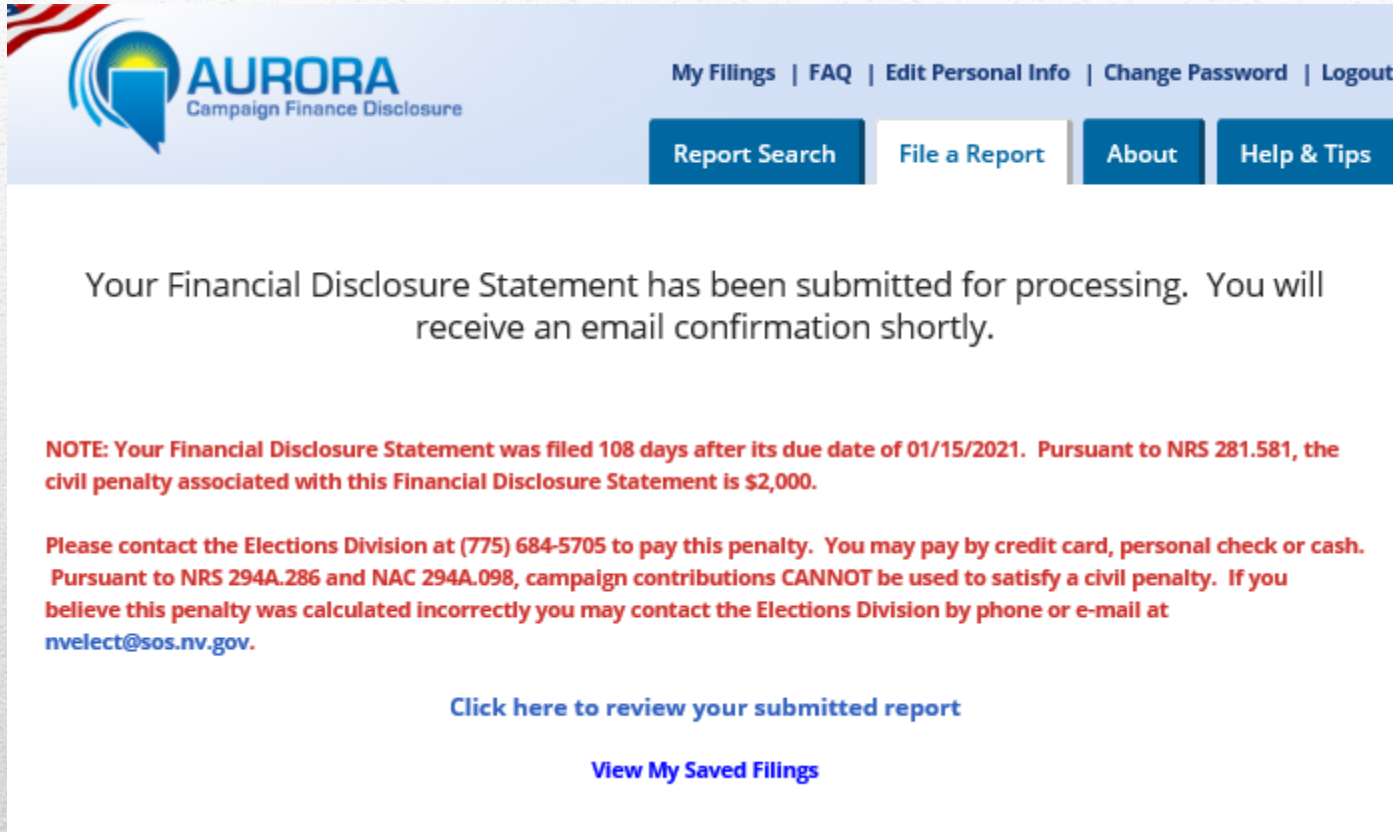

Penalties

Penalty schedule as provided in NRS 281.581:

- If the report is filed 1-10 days late, \$25 for each day the report is late.
- If the report is filed 11-20 days late, \$50 for each day the report is late.
- If the report is filed 21-30 days late, \$100 for each day the report is late.
- If the report is filed 31-45 days late, \$250 for each day the report is late.
- If the report is filed more than 46 days late, the maximum violation is \$2,000.
- A Waiver Request will be sent to candidate or appointee. When the Secretary of State receives a reply stating why they were late in filing, the fees will be waived. The official will receive a Waiver Granted email.
